- The Company had appointed Central Depository Services (India) Limited ("CDSL") as the agency for providing remote e-voting platform to the Unsecured Creditors of the Company and necessary technical support was provided by Maheshwari Datamatics Private Limited, the Registrar and Transfer Agent ("RTA") of the Company, for processing e-voting and remote e-voting.
- The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013, rules framed thereunder and SEBI (Listing Obligations and Disclosure Requirements)

Regulations, 2015 relating to e-voting and remote e-voting of the Meeting on the resolution contained in the Notice dated August 08, 2022 (dispatched on August 10, 2022).

- My responsibility as a Scrutinizer is to ensure that the process of voting by way of e-voting and remote e-voting of the Meeting was conducted in a fair and transparent manner and to submit a Scrutinizer's Report on the voting to the Chairperson of this Meeting on the resolution contained in the Notice dated August 08, 2022 (dispatched on August 10, 2022), based on the report generated from the electronic voting system provided by CDSL.
- The Cut-off Date for the purpose of determining the Unsecured Creditors entitled to vote through e-voting and remote e-voting of the meeting was Friday, December 31, 2021.
- The Company had completed the dispatch of Notice of meeting of Unsecured Creditors dated August 08, 2022 (dispatched on August 10, 2022) to those Unsecured Creditors whose name appeared in the certificate given by the Chartered Accountant certifying the list of Unsecured Creditors as on December 31, 2021 of Unsecured Creditors as on the Cut-off Date. As per the provisions of the Companies Act, 2013, the number of votes cast in respect of the resolution have been counted according to the proportion of amount held by the concerned Unsecured Creditors.
- An advertisement was published in English in "Business Standard" newspaper and translation thereof in Bengali in "Aajkal" newspaper on August 10, 2022 pursuant to Rule 20 of the Companies (Management and Administration) Rules, 2014 informing the Unsecured Creditors about the completion of dispatch of notice and other documents electronically by e mail, wherever applicable along with information as specified in the said Rules.
- The remote e-voting commenced on Friday, September 09, 2022 from 10.00 A.M (IST) and concluded on Tuesday, September 13, 2022 at 5.00 P.M (IST). The Unsecured Creditors as on the Cut-off Date, were entitled to vote on the resolution set out in the notice dated August 08, 2022 (dispatched on August 10, 2022) of the meeting of the Unsecured Creditors of the Company either by Remote e-voting or e-voting at the meeting.
- The remote e-voting module was disabled by CDSL for voting on Tuesday, September 13, 2022 at 5:00 P.M. (IST).

- On September 14, 2022 at 4:13 P.M. (IST), I have downloaded the e-voting report from the CDSL website viz, https://www.evotingindia.com/homepage.jsp.

- At the meeting convened pursuant to the order of the NCLT on September 14, 2022, the Chairperson after discussion on the resolution mentioned in the said Notice announced that the Unsecured Creditors present at the meeting who have not casted their vote by remote e-voting, can exercise their voting rights through e-voting at the Meeting.
- After the closure of voting at the said Meeting of Unsecured Creditors, the list of Unsecured Creditors who were present at the Meeting and who had casted their votes, their holding details and the details of the votes cast on the resolution was available for downloading.
- Thereafter, I counted the votes cast at the meeting. The votes cast through e-voting were reconciled with the records maintained by the Company and the certificate given by the Chartered Accountant certifying the list of Unsecured Creditors as on December 31, 2021, as had been filed by the Company with the NCLT.
